I would like to attend the IT Solutions Management (ISM) + Public Human Services Attorneys (PHSA) Education Conference & Expo on September 10-13, 2023, at the Gaylord Palms Resort & Convention Center in Kissimmee, FL.

The ISM + PHSA Conference & Expo is the largest educational event produced by APHSA. It attracts individuals in federal, state, and local government at all levels (Executive Offices [e.g., CEO, CTO, CDO, CIO, etc.]; Program and Project Directors and Managers [e.g., SNAP, TANF, Child Care, Child Support, Medicaid, etc.]; academia, research, and community-based organizations executives, and consultants who are aligned with the human services sector); along with private sector sponsors, many of whom are members of the Human Services IT Advisory Group (HSITAG) who present their solutions in the Expo Hall.

New this year is the joint venture with PHSA. This brings together two crucial mission-support areas of human services—technology and legal. With the addition of PHSA members (General Counsel, attorneys in specialized areas like Child Welfare, Medicaid, SNAP, TANF, Mental Health, American Bar members, private attorneys practicing areas related to human services, etc.), this conference will bring both the legal voice to conversations in sessions as well as attract additional agency staff who work in legal and technical support of their organizations. The ISM + PHSA Education Conference & Expo will also provide attorneys with the opportunity to attend a series of presentations and breakout sessions focusing on legal policies and practices that enhance the delivery and quality of human services programs—and earn continuing legal education credits! Topics include Medicaid, Child Welfare, Federal funding, justice and court involvement, cyber/data security, and more.

I have reviewed the agenda and feel the return on investment would be a major benefit as the event aligns to the priorities of our department and agency. It is a very worthwhile investment given the level of education and networking provided.

Over the course of the conference, I'll have access to:

- Education topics in the human services field as it relates to my role in the agency,
- The opportunity to earn Continuing Legal Education (CLE) credits to maintain my license (applicable to attorneys who attend approved legal sessions),
- The opportunity to earn Continuing Education Units (CEU) credits towards my certifications keeps me at the forefront of trends in project management, technology, etc.
- Presentations covering the latest trends and top-of-mind questions from human services experts and federal government leaders, and,
- Multiple opportunities to network with peers where I can exchange ideas with other leaders who have the same role or challenges.

I am seeking approval for the registration fee and travel expenditures. The full conference registration is \$775 for APHSA members / \$850 for non-members per person. Early registration ends on August 11, 2023. The conference hotel block closes on August 18, 2023. The Government room

rate is \$98 (and space is limited for government rooms) and the Standard group rate is \$259, plus taxes (currently at 14.5%). There is a resort fee of \$38 plus tax, per night for Sunday, Monday, Tuesday, and Wednesday.
